

BOOKING TERMS AND CONDITIONS :

The tenant, signatory to the present agreement shall under no circumstances whatsoever be entitled to invoke any right to maintenance of the premises during the term of the rental.

A non-smoking policy applies to all our accommodation. Bring tea towels, towels and cleaning products.

Arrival times at the campsite are between 16:00 and 20:00 on the first day and site must be vacated between 8:00 and 10:00 on the final day.

Arrival times for the camping pitch are between 12:00 (pas 14h?) and 20:00 on the first day and site must be vacated before 12:00 on the final day, **without which an (bizarre la formule)** additional day can be charged if the site is not vacated before noon.

*The balance (mobil-home) shall be paid no later than a month prior to the scheduled arrival date and the € 250 security deposit shall be paid upon arrival on the site. **Possible absence in the course of your stay shall not be taken into consideration** (c'est très ambiguë)

*A second deposit of € 50 shall be demanded for the **upkeep of the grounds (a verifier)**

*In the event of a **curtailed or shortened(ou l'un ou l'autre, non?)** stay for any reason whatsoever, the full rent for the camping pitch or accommodation shall be retained by **the proprietor or landlord (alors propriétaire ou propriétaire?)**. There will be no refund whatsoever. In such a case the campsite will be at liberty to dispose of the camping pitch or accommodation **quand?** In the event of the failure to take up the camping pitch or accommodation within 24 hrs after the scheduled arrival date, and without prior written notice to that effect, the campsite shall be entitled to dispose of the camping pitch or accommodation.

INVENTORY OF FIXTURES, SECURITY DEPOSIT FOR RENTAL.

An inventory of fixtures will be conducted at the beginning and at the end the rental term, in the presence of the tenant (or their proxy). This property inventory shall constitute the sole reference in the event of a dispute arising from the inventory of fixtures. The said inventory will be conducted between 8:00 and 10:00 on the departure date of the tenant, except with prior written consent of the landlord. The security deposit shall be refunded to the tenant upon completion of the inventory on the departure date, after deductions have been made for possible losses, repairs, reconditioning and/or including cleaning. A fixed sum of € 50 shall be retained if the property is not returned in pristine condition. In the event of an anticipated departure as a result of which the property inventory cannot be conducted, the security deposit shall be returned by the landlord on the day the tenant departs, and in any case no later than a week later.

INSURANCE : The customer shall be held liable for any damage that is of their doing. The customer is advised to take out a holiday insurance policy to cover any risks they may be exposed to.

ANIMALS: Categories 1 and 2 dogs (French dangerous dog act) are not allowed on the campsite. Animals weighing under 10 kg are allowed on the site (maximum of 1 with a supplement). A valid and updated vaccination certificate must be provided for each animal on the site. Each and every dog on the campsite must be on a leash.

CANCELLATION: cancellation of your reservation of campsite rental pitch shall only be given notice of by means of registered letter, to the excursion of every other means of communication (phone, email, fax or unregistered letter). If you refuse to subscribe to the cancellation insurance the cancellation is given more than 30 days prior to the initially scheduled arrival date, the campsite will refund the deposit in its entirety upon deduction of a € 15 booking fee. In the event of cancellation less than 30 days prior to the arrival date, the camping shall retain the deposit Cancellation insurance also covers curtailment or early departures.

ADDITIONAL FEE SERVICES:

FREE ACCESS: The pool is open from the beginning of May to the end of September from 10:00 to 20:00 each day.

Rental of this camping pitch will be effective if I receive:

- a dated and signed copy of this agreement (the second copy will be kept by the tenant)
- a deposit to be paid by Bank card, bank cheque (for French people only) or postal order to camping la Garrigue, holiday vouchers, traveler cheques or transfer.
- Your reservation shall only become effective upon being confirmed by the camping.

HYGIENE AND SANITATION: Basic rules of hygiene must be adhered to in the bathrooms and when washing up. Refuse may not be deposited directly into the bins but must be collected garbage bags before being dropped into the bins. It is strictly forbidden to put these bags in the bathroom bins, they must be put in the refuse bins at the entrance to the campsite.

SECURITY: The management of the campsite rejects all liability for theft or accidents that take place within the campsite.

NOISY: Noisy activities are prohibited between 22:00 and 9:00 except those organised by the campsite.

POOL: Swimming pool rules and regulations must be respected. Only swimming costumes are allowed at the pool, no shorts.

CHILDREN: They are under the exclusive supervision of their parents who are civilly and criminally responsible for their children especially when it comes to making use of the pool and the games at their disposal.

Camping on our campsite shall be understood to imply the unconditional acceptance of our rules and regulations. Any breach of these rules and regulations shall result in the immediate expulsion of the perpetrator. Any disputes ensuing from or related to this agreement shall be subject to the exclusive jurisdiction of the courts of Cahors.
